

MINUTES OF THE ELECTORAL BOARD CANVASS November 7th, 2018

An open session meeting of the Orange County Electoral Board was called to order by the Secretary on Wednesday, November 7th, 2018 at 10:00 a.m. in RM 268, located at 146 Madison Rd., Orange, VA 22960 to conduct the canvass of the November 6th, 2018 Election.

- I. *After being called to order, the board moved directly into a closed meeting to discuss provisional ballots. The board reconvened at 10:15 for provisional research and to make copies of logs for representatives of political parties.*

The board voted to not count the provisional ballots, due to more research.

- II. *The board adjourned for a brief lunch recess at 10:45 am.*
- III. *Reconvened into closed session at 11:23 am.*
- IV. *The board comes out of closed session and into open session at 11:34 am to count votes.*

There are thirty-five provisional ballots. Eight provisional ballots: yes. Two provisional ballots: pending.

101 Barboursville- Results tape and Ballot Record Report matches reported numbers. One voter not checked into EPB. 0 provisional ballots.

102 Gordonsville- Results tape matches reported results.

201 Lightfoot- Results tape matches reported results.

202 Mine Run- Results tape matches reported numbers.

301 Prospect Heights- Results tape does not match reported numbers. Discrepancy: nothing written down to explain why. Three ballots cast, missing on EPB.

302 Unionville- Results tape and Ballot Record Report matches reported numbers.

401 LGPS- Results tape matches reported results. One provisional checked into EPB.

402 LGMS- Results tape and Ballot Record Report matches reported numbers. Discrepancy: One voter declined to vote after being checked in.

501 LOW Clubhouse- Results tape matches reported numbers.

502 Comm. Center- Results tape and Ballot Record Report matches reported numbers. Discrepancy: EPB check-in error.

CAP- The results tape matched the reported results. 20 AB ballots rejected, 12 unused. All other paperwork was in order.
